hereinafter referred to as "agencies," SETHU BHASKARA AGRICULTURAL COLLEGE AND RESEARCH FOUNDATION, VISALAYANKOTTAI, KARAIKUDI as SBACRF, fully recognizing that academic exchanges and cooperation between the two agencies would be beneficial to all


concerned, hereby affirm their intention to encourage such academic exchanges and cooperation for the academic development of the students


As a general declaration of intent, the two agencies agree to act as follows:

1. The two agencies will encourage the following activities for ACADEMIC BENEFIT of students
 - a) Utilize the expertise, instruments, and laboratory facilities available at SBACRF, Karaikudi for field work and lab usage
 - b) Utilize the expertise of Principal of SBACRF and faculties and resources of SRI RAAJA RAAJAN COLLEGE OF ENGINEERING AND TECHNOLOGY, KARAIKUDI to ensure the students lab usage and field work.
 - c) Exchange of Students, Professors, Researchers and Technical personnel for student academic development.
 - d) Collaborative research and joint academic meetings when on required.
 - e) Exchange of information, publications and materials for academic and innovation purposes as per mutual understanding.
 - f) Other activities mutually agreed upon by the two agencies for academic betterment of students.
2. Therefore mentioned activities shall be realized by means of consultation and exchange of relevant information by appropriate members of the two agencies.
 - a. Shared access to lab facilities and equipment.
 - b. Joint mentorship programs for students.
 - c. Collaborative workshops, seminars, and training sessions.
 - d. Coordinated networking events to connect students with industry experts.
 - e. Mutual support for academic betterment of students
 - f. Assistance in securing funding through joint initiatives and presentations.
3. This Agreement shall become effective for Five years immediately from 09.09.2024 to 06.08.2029 upon being signed by the official representatives of the two agencies.
4. The terms and conditions of this agreement shall not be disclosed to any third parties without the prior written consent of both Parties. This agreement shall be governed by the laws of Union of India and State of Tamil Nadu.

This Agreement may be amended by mutual written agreement. This specific agreement holds good for the field work and lab usage in SETHU BHASKARA AGRICULTURAL COLLEGE AND RESEARCH FOUNDATION, VISALAYANKOTTAI, KARAIKUDI, SRI RAAJA RAAJAN COLLEGE OF ENGINEERING AND TECHNOLOGY, KARAIKUDI on a minimum cost basis wherever applicable.

Furthermore, SETHU BHASKARA AGRICULTURAL COLLEGE AND RESEARCH FOUNDATION, VISALAYANKOTTAI, KARAIKUDI, agrees that in its future internship training, field visits and industrial visits and ensure sustainable development of the students of SRI RAAJA RAAJAN COLLEGE OF ENGINEERING AND TECHNOLOGY, KARAIKUDI as per the demand arises and faculty members of the SETHU BHASKARA AGRICULTURAL COLLEGE AND RESEARCH FOUNDATION, VISALAYANKOTTAI, KARAIKUDI, shall be utilized if required.
